| 5. Title of the notified document: Draft Regulation of the Minister of Agriculture concerning Mandatory Enforcement of Indonesian National Standard for White Crystal Language(s): Indonesian Number of pages: 7 |
| 6. Description of content: This draft regulation has been issued as a legal basis in the mandatory enforcement of Indonesian National Standard for white crystal sugar. This draft regulation aims to (i) guarantee and protect people from the circulation of white crystal sugar product that does not meet safety and quality requirements; (ii) providing legal certainty for businesses in conducting the production and distribution of white crystal sugar; (iii) facilitate traceability from the possibility of distortion and circulation of white crystal sugar; and (iv) improve the competitiveness of white crystal sugar. This draft regulation stipulates as follows: a) White crystal sugar both domestic production and/or imported must fulfill the requirements of Indonesian National Standard for White Crystal Sugar. White crystal sugar set out in the draft regulation are white crystal sugar with HS Tariff Number 1701.91.00.00 and 1701.99.90.00; b) Companies that manufacture or import white crystal sugar is a company that has had a User Product Certificate-SNI (SPPT-SNI) issued by the Certification Body for Products (LSPro); c) Imported white crystal sugar has to be accompanied by SPPT-SNI, attached with Certificate of Analysis (CoA) issued by a laboratory accredited by the State Accreditation Body. |
