<p>6. <b>Description of content:</b> The Regulation of the Minister of Agriculture No. 47/Permentan/OT.140/4/2013 is a substitute of the previous regulation No. 60/Permentan/OT.140/9/2012 concerning Import Recommendation of Horticultural Products that has been notified as G/SPS/N/IDN/55 on 23 October 2012.</p> <p>Principles of regulation in the Regulation of the Minister of Agriculture No. 47/Permentan/OT.140/4/2013 concerning Import Recommendation of Horticultural Product are as follows:</p> <ol style="list-style-type: none"><li>1. This regulation stipulates 39 types of imported horticulture products. This means that there is a reduction of 18 types of horticultural products regulated in the previous regulation. The type of horticultural products that are no longer regulated in the regulation are garlic, garlic powder, chili powder, cabbage, chrysanthemum, heliconia flowers, orchid flower, and some processed horticultural products.</li><li>2. Submission of application for obtaining RIPH can only be served by electronic systems online through a determined web portal (one-stop service INATRADE Ministry of Commerce).</li><li>3. RIPH published twice within one year applicable for the period of January to June and June to December. RIPH apply for fresh horticultural products for industrial raw materials, processed for industrial raw materials, while processed for consumption issued once within one period for one company.</li><li>4. RIPH published for the period of January to June no later than the end of December last year, and for the period of July to December RIPH published no later than the end of June of the current year.</li><li>5. By the stipulation of this regulation, the Regulation of the Minister of Agriculture No. 60/Permentan/OT.140/9/2012 concerning Import Recommendation of Horticultural Products is revoked and no longer effective.</li></ol>
