6. Description of content: This regulation specified the maximum level requirement of the emulsifying salt which can be used as a food additive in processed food. The names of the emulsifying salt which are allowed consist of: <ol style="list-style-type: none">1. Sodium dihydrogen citrate (INS.311 (i));2. Trisodium citrate (INS.331 (iii));3. Potassium dihydrogen citrate (INS.332 (i));4. Tripotassium citrate (INS.332 (ii));5. Monosodium orthophosphate (INS.339 (i));6. Disodium orthophosphate (INS.339 (ii));7. Trisodium orthophosphate (INS.339 (iii));8. Monopotassium orthophosphate (INS.340 (i));9. Dipotassium orthophosphate (INS.340 (ii));10. Tripotassium orthophosphate(INS.340 (iii));11. Edible gelatin (INS.428);12. Disodium diphosphate (INS.450 (i));13. Tetrasodium diphosphate (INS.450 (iii));14. Tetrapotassium diphosphate (INS.450 (v));15. Dicalcium diphosphate (INS.450 (vi));16. <ul style="list-style-type: none"> • The maximum level requirement of the emulsifying salt in each food category is mentioned in Annex 1 as an integral part of this regulation. • The emulsifying salt in processed food must be proven by a certificate of analysis. • The type and use of an emulsifying salt other than that listed in Annex 1 should only be used after obtaining approval from the Head of NADFC. • The emulsifying salt and processed food containing emulsifying salt which has marketing approval must be adjusted to be in line with this regulation no later than one year from the date of enactment. • The emulsifying salt and processed food containing emulsifying salt which is submitted before the prevailing of this regulation will be processed based on the Regulation of Minister of Health No. 722/Menkes/Per/IX/1988 on Food Additive as amended by the Regulation of Minister of Health No. 1168/Menkes/Per/X/1999. The validity period of this marketing approval will be one year.
