Description of content: This regulation is intended as the basis for the implementation of quarantine actions on the importation and exportation of reproductive biological materials to, from and within the territory of the Republic of Indonesia to ensure that the reproductive biological materials imported and/or exported to, from and within the territory of the Republic of Indonesia are free from animal quarantine diseases that can be transmitted through reproductive biological materials. The scope of this regulation includes: a. Import requirements: quarantine requirements, technical requirement and management of diseases, requirements on status and situation of animal quarantine diseases in the country of origin, packing requirements, storage requirements, transportation requirements, and documents requirements; b. Requirements on import and/or export between areas within the territory of the Republic of Indonesia: requirements on status and situation of animal quarantine diseases in the country of origin, packing requirements, storage requirements, transportation requirements, and documents requirements; c. Export requirements; d. Assessment procedures in the countries and area of origin: <ul style="list-style-type: none">• procedures for pre-shipment inspection in the country of origin (parameter of Pre-Shipment Inspection; assessment on: reproductive biological materials, donor animal, packaging materials, storage, transportation; and report of the results of assessment in the country of origin);• procedures for In-Line Inspection in the place of production (parameter of assessment, assessment on: reproductive biological materials, animal donor, packaging materials, storage, transportation; and report of the results of assessment in the country of origin); e. Quarantine actions for importation and/or exportation to, from and within the territory of the Republic of Indonesia on reproductive biological materials.
