This regulation's date of entry into force is on 1 October of 2020. Concerned Points of this measures : 1. Raw uncleaned swallow bird's nest could not be entered or taken out to or from Indonesia. 2. The arrangement of maximum limit standard for microbiological, chemical and physical contamination content as well as water content for importation of bird's nest into Indonesia.
