5. Title of the notified document: Draft Regulation of the Head of Indonesian National Agency for Drug and Food Control Concerning Prohibited Materials in Processed Foodstuff Language(s): Indonesia (summary in English is provided). Number of pages: 3

Description of content: The regulation specifies the list of prohibited materials that may impair and/or risk human health in the activity or process of food production, processing, packaging, storage, transportation and/or distribution, such as: alkannin; Borax; formaldehyde; Rhodamine B, D&C Red No. 9, C.I. Food Red 15; Chloramphenicol; Brominated vegetable oil; etc. (a) The implementation of this regulation is controlled by the Head of Indonesian National Agency for Drug and Food Control; (b) Any violation of the provisions may be subject to criminal sanctions and administrative sanction, such as: <ul style="list-style-type: none">• written warning;• prohibition from distribution temporarily and/or instruction to withdraw the food products from distribution, and/or food destruction;• temporary production halt; and/or• cancellation of Approval Letter of Food Registration.
