Description of content: This regulation is intended as a basis for the implementation of quarantine measures toward the importation and exportation of ruminants into and from the territory of the Republic of Indonesia, and as a guideline for everyone importing and exporting the ruminants into and from the Republic of Indonesia. This regulation aims to guarantee that imported and exported ruminants into and from the territory of the Republic of Indonesia are free from animal quarantine diseases. This regulation covers requirements of importation and exportation of ruminants into and from the territory of the Republic of Indonesia, including: <ul style="list-style-type: none">- requirements of the country of origin- document- shipment- quarantine measures at the entry and exit point, in the country of origin and/or on the transport means, in quarantine installation, and outside the exit point.
