| <b>6. Description of content:</b> This regulation is intended as a basis for any person who would like to import or export the animal that transmit rabies into and outside the territory of the Republic of Indonesia, and/or inclusion or exclusion the animal that transmit rabies within areas in the territory of the Republic of Indonesia.<br><br>This regulation aims to prevent the introduction of rabies into the territory of Indonesia, to prevent the spread of rabies within areas in the territory of Indonesia, and prevent the exit of rabies from the territory of Indonesia.<br><br>The scopes of the regulation are: <ul style="list-style-type: none"><li>– Importation of animals that transmit rabies into the territory of the Republic of Indonesia;</li><li>– Exportation of animals that transmit rabies from the territory of the Republic of Indonesia;</li><li>– Inclusion or exclusion of animals that transmit rabies within areas in the territory of the Republic of Indonesia;</li><li>– Quarantine actions toward animals that transmit rabies against the outbreak conditions;</li><li>– Quarantine actions toward animals that transmit rabies for contest, exhibition and diplomatic purposes.</li></ul><br>The importation of animals that transmit rabies into the territory of the Republic of Indonesia could come from country that is free from rabies with vaccination or without vaccination, and from country that is not free from rabies. This importation of animal that transmit rabies must meet Indonesian Quarantine requirements and subject to quarantine |
