This draft regulation was made as a basis to assure the quality of distributed cocoa beans in order to improve the competitiveness and added value as well as providing industrial raw materials. This draft regulation aims to: <ul style="list-style-type: none">• increase competitiveness and value added of Indonesian cocoa beans;• support the development of cocoa raw material industry in the country;• provide protection for the consumers from cocoa beans that do not meet quality requirements;• improve the Indonesian cocoa farmers' income; and• facilitate traceability of the deviation possibility on cocoa production and circulation. The scopes of the regulation are as follows: <ul style="list-style-type: none">• Institutional;• Quality requirements and handling;• Marketing; and• Control.
