5. Title, language and number of pages of the notified document: Draft Decree of Minister of Agriculture concerning Additional Obligations For Plant Quarantine (available in Indonesia, 8 pages)
6. Description of content: This draft decree of Minister of Agriculture concerning Additional Obligations For Plant Quarantine as follows : (a) Technical requirements: Carrier Media should come from areas free of Plant Quarantine pests; Carrier Media from areas not pest-free should have prior specific treatment at the country of origin stated in the Phytosanitary Certificate; If a transit occurred, carrier media should be treated by plant quarantine measures in the transit country stated in the Phytosanitary Re-Export Certificate; Carrier Media should be packed with specific material which are mentioned on the label; Carrier Media should be repacked in the transit country; Carrier Media should be carried with specified kinds and routes of vehicle transportation; If a transit occurred, the Carrier Media should not be removed from the transport vehicle in the transit country. (b) Documentary requirements: Plant Seed Import Permit; Phytosanitary Certificate accompanied by Treatment Certificate from country of origin; Certificate of country of origin; Arrival schedule of vehicle transportation; Inward manifest; Cargo manifest; Bill of Lading (BL); Airway Bill (AWB); Packing list; Passenger declaration.
