Description of content: This regulation is intended as the basis for the implementation of animal quarantine measures on the importation and exportation of poultry into, from and within the territory of Indonesia to prevent the introduction and the spread of animal quarantine diseases that can be transmitted through poultry.</p> <p>Scope of regulation as follows:</p> <p>1. Importation and Exportation of Poultry Into and From the Territory of Republic of Indonesia The importation and exportation of poultry into and from the territory of Indonesia shall meet the quarantine requirements as follows:</p> <p>a. to be accompanied by quarantine documents as follows:</p> <p>i. Animal Health Certificate issued by competent authority in the country of origin (for the importation of poultry from overseas into the territory of Indonesia);</p> <p>ii. Animal Health Certificate issued by quarantine veterinarian in the exit point (for the exportation poultry from the territory of Indonesia);</p> <p>b. shall be imported and exported through the designated point of exit and entry;</p> <p>c. shall be notified and presented to the quarantine officer at the point of exit and entry for quarantine measures;</p> <p>d. subject to quarantine measures conducted by animal quarantine officers.</p> <p>2. Importation and Exportation of Poultry Within the Territory of the Republic of Indonesia The importation and exportation of poultry within the territory of Indonesia shall meet the quarantine requirements as follows:</p> <p>a. subject to quarantine measures conducted by animal quarantine officers at the point of entry and exit.</p> <p>b. in terms of exported poultry in the form of hand carry, animal health certificate requirements issued by quarantine veterinarian in the exit point can be excluded.</p>
